New President/COO Appointed



The Clinton County Electric Cooperative's Board of Trustees recently appointed Bob Kroeger as its newest President/Chief Operating

Officer. Bob succeeds Mike Johnson who resigned from CCECI on July 31, 2016. Bob has over 23 years of experience in the rural electrification program, with the last 16 of those years spent at Clinton County Electric Cooperative.

Bob earned a Bachelor of Science degree in Electrical Engineering Technology from Southern Illinois

University in Carbondale. He started his career in the cooperative arena at Egyptian Electric Cooperative in Murphysboro. During his seven years of employment at Egyptian, he worked his way up from Staking Engineer to Assistant Engineer. In 2001, Bob was hired as CCECI's Engineer and had recently been promoted to Manager of Engineering & Operations.

In the past, the Board and management of CCECI have used the phrases "safe and reliable" and "fair and reasonable" to guide them in their decision making, and Bob plans to continue down that path. He said, "Most importantly, I will continue to be

committed to the safety of the members and employees. I will continue the upgrades and improvements to CCECI's infrastructure through programs such as the Copper Replacement and Pole Testing/Replacement Programs." Bob went on to say, "I will also work to maintain financial stability through fair and reasonable rates, and I look forward to serving the members of CCECI." Bob's responsibilities as President/COO began on October 1, 2016.

Ten 2017 IEC Memorial Scholarships Available

Clinton County Electric Cooperative has announced that the Illinois electric cooperatives will award nine academic scholarships in 2017. These scholarships will be awarded to high school seniors through a memorial scholarship fund designed to financially assist deserving students in the "electric cooperative family." In addition, a tenth scholarship – to assist with costs in attending an electric lineworker school – will also be offered.

The ten scholarships of \$2,000 each will be awarded in 2017 through the Thomas H. Moore Illinois Electric Cooperatives (IEC) Memorial Scholarship Program.

Five scholarships will be awarded to high school seniors who are the sons or daughters of an Illinois electric

cooperative member receiving service from the cooperative. A sixth scholarship, the Earl W. Struck Memorial Scholarship, will be awarded to a student who is the son or daughter of an Illinois electric cooperative employee or director. Three additional scholarships are reserved for students enrolling full-time at a two-year Illinois community college who are the sons or daughters of Illinois electric cooperative members, employees or directors.

The tenth annual scholarship, the "LaVern and Nola McEntire Lineworker's Scholarship," was awarded for the first time in 2011. This \$2,000 scholarship will help pay for costs to attend the lineworker's school conducted by the Association of Illinois Electric Cooperatives in conjunction with Lincoln Land Community

College, Springfield, Ill. LaVern McEntire served as a lineman for McDonough Power Electric Cooperative from 1949 until 1991. He and his wife, Nola, endowed the scholarship to financially assist deserving individuals in becoming trained lineworkers. Sons and daughters of cooperative members; relatives of cooperative employees or directors; and individuals who have served or are serving in the armed forces or National Guard are all eligible for the lineworker's scholarship.

Lineman's Safety Rodeo

Team events included the Hurt Man Rescue, Egg Climb (linemen climb a 30-ft pole with a raw egg in their mouth), H-structure Obstacle Course, Single Phase and Neutral Conductor Lift, and Primary URD Termination. Foreman Mike Faust and Apprentice Linemen Jacob Haselhorst, Justin Hubert, and Kyle Wiegmann performed well in all of the events, and placed third in the Primary URD Termination Event. Apprentice Lineman Kyle Wiegmann competed individually in the Egg Climb, Hurt Man Rescue, and H-Structure Obstacle Course. Clinton County Electric Cooperative's Operations Superintendent, Brian Taylor, spent the day as a judge for the Primary URD Termination event.
